SELECTION CRITERIA

- Good standing as a first-year law student at an ABA-accredited law school. Students in four year evening programs should not apply until after their second year of law school.
- Demonstrated academic excellence, personal and professional accomplishments, commitment to community service, and meaningful contribution to the diversity of the legal profession.
- Involvement in leadership roles, or opportunities where you have led others toward a common goal or project.
- Committed to living and practicing law in Portland, Salt Lake City, or Seattle following law school graduation, and having an expressed interest in our practice areas.

APPLICATION MATERIALS

- One-page personal statement which clearly addresses the above selection criteria.
- Cover letter in which you indicate the office(s) you are applying to.
- Current résumé.
- Three professional references.
- Undergraduate and law school transcripts (unofficial copies are fine). If your 1L grades have not been posted at the time you apply, you will be able to add a transcript, when available, to your application materials through the link provided to you in your application confirmation email.
- A legal writing sample that has not been edited by others (5 to 10 pages, double-spaced).
